In accordance with the provisions of the art. 142 paragraph 2 letter c) of the Law no. 31/1990 on trading companies, republished, as further amended, and of the art. 15.1 letter c) of the Articles of Incorporation of Rompetrol Well Services S.A., Mr. Florea Georgian Stefan was appointed General Manager, starting as of October 18<sup>th</sup>, 2021, for a mandate valid until 29.04.2022 (date upon which the mandates of the directors resolving upon the present nomination expire).

Mr. Georgian Stefan Florea has graduated from the Petroleum Gas University Ploiesti. He holds a master’s in reservoir engineering from the Petroleum Gas University Ploiesti.
